



Account Aggregation Request Form

_____ (hereinafter “Building Owner”) has made a determination that it is subject to the Energy Empowerment Ordinance (Sections 18-500 through 18-508) that has been enacted by the City of Kansas City, Missouri (hereinafter “KCMO”). Under the ordinance, KCMO requires owners of certain building sizes to benchmark and report annual energy use. Building Owner has requested assistance from the Kansas City Power & Light Company (hereinafter “KCP&L”) in gathering aggregated data for building(s) subject to the ordinance. KCP&L is willing to provide such assistance, subject to the following conditions:

- 1) KCP&L will not provide data that is identifiable to any specific KCP&L customer in the building other than the Building Owner. If a multi-tenant building has fewer than five (5) KCP&L metered account holders that are different than the Building Owner, then Building Owner is required to obtain an executed release from each account holder in the form attached hereto as Attachment A and provide the releases to KCP&L before this request form will be deemed to be complete.
- 2) The information is provided “As Is”. While KCP&L will endeavor to provide accurate data based on the information provided, it makes no representations or warranties that the data will error-free or complete.
- 3) If an Agent Company is identified below, Building Owner hereby authorizes KCP&L to provide the necessary information for all Building Owner accounts to the Agent Company.
- 4) Building Owner shall indemnify, defend and hold harmless KCP&L and its officers, employees and agents from all claims, liabilities and damages incurred by KCP&L as a result of the assistance it provides under this agreement, except to the extent caused by the gross negligence or willful misconduct of KCP&L.
- 5) Incomplete or inaccurate request forms cannot be processed. KCP&L requires 30 days to process a complete request form before aggregation data can be provided.
